RCDI grants are awarded to help nonprofit housing and community development organizations, low-income rural communities and federally recognized tribes support housing, community facilities and community and economic development projects in rural areas.

Language being requested: *Provided*, For the cost of rural community facilities grants as authorized by section 381 E and described under section 381(E) (d)(1) of the Consolidated Farm and Rural Development Act ... *Provided That* \$8,000,000 of the amount appropriated under this heading shall be available for a Rural Community Development Initiative; *Provided further*, That such funds shall be used solely to develop the capacity and ability of private, nonprofit community-based housing and community development organizations, low-income rural communities, and Federally Recognized Native American Tribes to undertake projects to improve housing, community facilities, community and economic development projects in rural areas: *Provided further*, That such funds shall be made available to qualified private, nonprofit and public intermediary organizations proposing to carry out a program of financial and technical assistance: *Provided further*, That such

intermediary organizations shall provide matching funds from other sources, including Federal funds for related activities, in an amount not less than funds provided.

- 9. Justification for request: RCDI is the only federal program designed to help rural communities build their capacity to improve housing, community facilities, and economic development. For example in , Lewistown, Montana (population 5,918), RCDI technical assistance has gone to a small and emerging CDFI; helped 4 new businesses and expand one business and one nonprofit; created 49 new jobs; and secured some \$3.6 million in new federal, state, foundation and in-kind funding.
