Dear Member of Congress:

We, the undersigned 1,466 rural organizations and advocates, write to express our support for U.S. Department of Agriculture (USDA) Rural Housing programs and our strong opposition to the reductions proposed in the President's Fiscal Year 2015 (FY15) Budget Request. We respectfully request appropriations for USDA Rural Housing and Water and Wastewater Disposal programs at no less than the current FY14 rate.

Between 2010 and 2014, the President requested over \$1 billion in cuts to USDA's loans and grants for business development, water and waste disposal, and rural housing. As a result, these programs have been cut by 35 percent.

This year, the Administration is at it again. The FY15 Budget Request proposes to cut Rural Development programs by an additional \$270 million. If enacted, this would amount to a 57 percent reduction in funding since 2010.

Specifically, the President's Budget proposes to cut the Section 502 Direct Loan program by more than \$540 million or 60 percent and recommends reducing the Section 523 Mutual Self-Help Housing program by \$15 million or 60 percent. Both of these programs provide low-income, rural families an opportunity to gain homeownership. As a result, 4,600 fewer rural families will be able to access affordable mortgages, creating 8,100 fewer jobs and generating \$407 million less in local wages.

In addition, the President's budget proposes to reduce Rural Water and Waste Disposal grants by \$160 million or 34 percent. These grants help small, remote, and poor rural communities build clean, safe, and affordable water and sewer systems for residents.

We strongly urge you to reject the Administration's budget plan. These proposed reductions will only make it harder for low-income families, the elderly, and persons with disabilities to access decent, healthy, and affordable housing and will hurt struggling rural economies.

Through its budget, USDA has made it clear that rural America's community development needs are not a priority for this Administration. Congress considered and rejected similar proposals in the FY14 budget. We urge Congress to again reject the unwise and unwarranted cuts proposed in the President's FY15 Budget Request for USDA Rural Housing and Community Development programs.
